Legal information

The **Apex Challenge** became a registered charity in 2004 and is governed by its own declaration of trust. The charity operates throughout England and Wales. It is also part of the Scout Association and operates under its rules and guidelines. Its aims are 'to promote the development of young people in achieving their full physical intellectual social and spiritual potentials, as individuals, as responsible citizens and as members of the local, national and international communities particularly by the provision of specialised outdoor activities'.

The Apex Challenge currently has three trustees. These first trustees are permanent appointments:

2014: Review of the Year

Although our two flagship competitions were postponed during 2014, there were still opportunities for Scouts to take part in Apex Challenge events, albeit on a smaller scale.

Apex gets intense at Scouttastic



Following a successful one-day event last year, South Yorkshire's annual county camp, Scouttastic, returned in 2014 for a full weekend. Once again the Apex Challenge was there to give Scouts of all ages the chance to experience what makes our events so special.

Teams raced against the clock to navigate around a course of challenging obstacles and other control points in the fastest possible time.

Several new obstacles were created to give teams a unique new challenge to complete and we worked hard to make sure more teams than ever were able to take part in the event.

Daring Duck Rescue

Part of what makes the Apex Challenge events such a success is the contribution made by the dozens of people who look after our activities.

The organisers of the Yorkshire Rose Challenge are regulars at our events and this year we once again supported them by providing an activity for their event.

A good sense of balance was needed as teams navigated a low ropes course to rescue as many rubber ducks as possible from a 'toxic' pond. It was definitely harder than teams originally thought!

Independent examiner's report

I report on the accounts of the Apex Challenge for the year ended 31 October 2014 which comprise the 'Statement of receipts and payments' and 'Statement of assets and liabilities' set out on pages 5 and 6.

Respective responsibilities of Trustees and Examiner

The Apex Challenge trustees are responsible for the preparation of the accounts. They consider that an audit is not required for this year (under Section 144 of the Charities Act 2011 (the Charities Act)) and that an independent examination is needed.

It is my responsibility to:

- Examine the accounts (under Section 145 of the Charities Act);
- Follow the procedures laid down in the General Directions given by the Charity Commissioners (under Section 145(5)(b) of the Charities Act); and

Basis of Independent Examiner's report

My examination was carried out in accordance with the General Directions given by the Charity Commissioners. An examination includes a review of the accounting records kept by the Apex Challenge and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters.
